# ARTICLE I NAME

The Name of this corporation shall be Christopher Lee Hart Enterprises, Inc.

# ARTICLE II COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department of State. This corporation's duration shall be prepetual.

# ARETICLE III PURPOSE
