ARTICLES OF INCORPORATION

LEVIE FUNDING GROUP, INC.

The undersigned, for the purpose of forming a Corporation under the Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name; Principal Office

The name of this Corporation shall be LEVIE FUNDING GROUP, INC. (the "Corporation"). 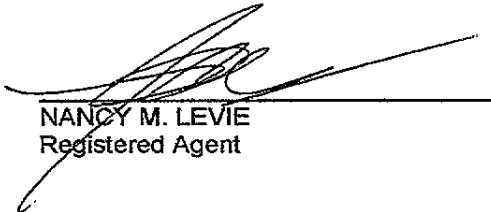
