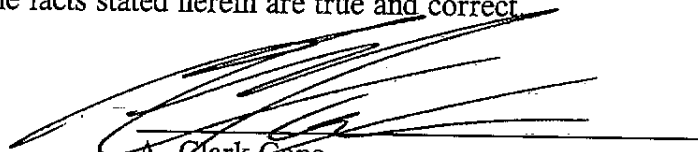
**ARTICLE VIII**

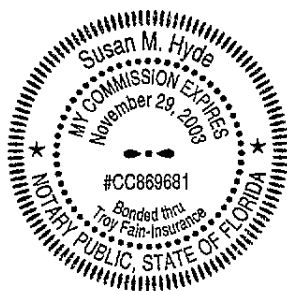

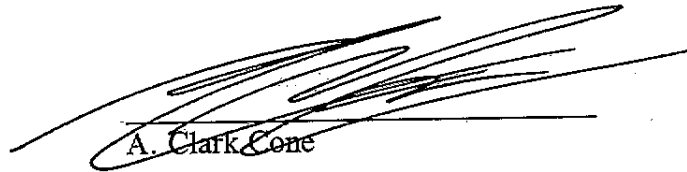
