The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLES OF INCORPORATION OF FUSSY GARMENT CARE OF SW FLORIDA, INC.

- I. <u>NAME</u>: The name of the corporation is: FUSSY GARMENT CARE OF SW FLORIDA, INC.
- II. TERM OF EXISTENCE: Unlimited
- III. <u>NATURE OF BUSINESS</u>: The corporation may engage in any activity or business permitted under the laws of the United States or the laws of the State of Florida.
- IV. <u>CAPITAL STOCK</u>: The aggregate number of shares of stock that this corporation is authorized to issue is one thousand (100) shares. Such shares shall be of single class and shall have a par value of one dollar (\$1.00) per share.
- V. STOCK TRANSFERS-CORPORATION'S RIGHT OF FIRST REFUSAL:

No shareholder shall have the right to sell, assign, pledge, encumber, transfer or otherwise dispose of any of the shares of the corporation without first offering such shares for sale to the corporation at a price to be agreed upon between the offerer and the corporation. If the parties cannot agree as to the value of the shares each party shall select an arbitrator and two arbitrators so selected shall act as referee. A majority vote of the three shall determine the value. Such offer shall be in writing, signed by the shareholder; shall be sent by registered or certified mail to the corporation at its principal place of business; and shall remain open for acceptance by the corporation for a period of thirty (30) days from the date of mailing. If the corporation fails or refuses within such period to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of his shares as he may see fit. On the death of any shareholder, the corporation shall have the right to purchase all shares owned by such shareholder immediately prior to his death on the terms set forth above, and this provision shall be binding on the executor, administrator, or personal representative of each shareholder.

- VI. <u>ADDRESS AND REGISTERED AGENT</u>: The street address of the initial registered office of the Corporation is: FUSSY GARMENT CARE of SW FLORIDA, Inc. c/o Christine Seyler, 5489 Cove Circle, Naples, FL 34119, and the name of its initial registered agent is: Christine Seyler.

- X. MANAGEMENT OF THE CORPORATION: The corporation shall have no board of directors and all the business and affairs of the corporation shall be managed under the direction of the shareholders.
- XI. <u>AMENDMENT OF ARTICLES OF INCORPORATION</u>: These articles may be amended in the manner provided by law. Every amendment shall be proposed by any shareholder and approved at a duly called shareholders' meeting by a majority of the shareholders entitles to vote therein.
