### ARTICLES OF INCORPORATION

The Undersigned incorporator(s) for the purpose of forming a corporation under the Florida business Corporation Act, hereby adopt(s) the following articles of incorporation.

### Article I - Corporate Name

#### UNITY INTERNATIONAL TRADING CORP.
