ARTICLES OF INCORPORATION OF A ALL AMERICAN COMPANIES, INC

The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of State of Florida.

ARTICLE I

The name of the corporation is: A All American Companies, Inc.

ARTICLE II TERM OF EXISTENCE

The corporation shall commence as of the date of filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence.
