The undersigned, for the purpose of forming a Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLES I - NAME

The name of the Corporation is MELL RUPP MARKETING INC.

The duration of the Corporation is perpetual.

ARTICLES III - NATURE OF BUSINESS
