ARTICLES OF INCORPORATION

Of

99 CENTS AND GROCERIES CORNER STORE, INC.

We the undersigned do hereby subscribe these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, Chapter 607, and subject to the following provisions.

ARTICLE ONE

The name of the corporation shall be:

99 Cents and Groceries Corner Store, Inc.

ARTICLE TWO

This corporation shall be perpetual existence and may engage in any activity or business permitted under the laws of the United States and the State of Florida; more specifically:

- A. The general nature of the business to be transacted by this corporation shall be: Retail Distribution and sale of perishable, nonperishable, and other retail goods.
- B. To manufacture, purchase, or otherwise acquire, and to own mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, good, wares, merchandise, real and personal property, and services of every class, kind and description.
- C. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses in the State of Florida, and in all other States, districts, territories, countries, or colonies.
- D. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate indebtedness as required.
- E. To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- F. To acquire by purchase, subscription or otherwise to receive, hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage pledge or otherwise dispose of or deal in and with any of the shares of the capital stock,

script, warrants, rights, bonds, debentures, notes, trust receipts, and other securities, obligation, chooses in action and evidence of indebtedness, or interest issued or created by any corporation, joint stock companies, syndicates, associations, firms, trusts, or persons, public or private, or by government of the United States of America, or by an foreign government, or by any state, territory, province, municipality, or their political subdivision or by any governmental agency, and as owner thereof to possess and exercise all rights, powers and privileges of ownership, including the right to execute consistent and vote thereon, and to do any and all acts necessary or advisable for the preservation, protection, improvement, and enhancement in value thereof.

- G. In general, to carry on any other business in connection with the foregoing, and have and exercise all the power conferred by the laws of Florida upon corporation formed under its laws, and to do any or all things hereinabove set forth to the same extent as natural persons might or could do submit to the limitations of the law.

ARTICLE THREE

The corporation shall issue 500,000 shares of common stock, having no par value. All or any part of the capital stock may be paid either in lawful monies of the United States of America, or in enter assets transferred to the corporation, at a true valuation as of the time of the exchange of the stock.

ARTICLE EIGHT

The corporation shall full power to carry on transact each or all of the business enumerated in Article Two of these Articles of Incorporation and shall have all the general and additional powers now and hereafter conferred upon it by law.

ARTICLE NINE

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed to the stockholders and approved at the stockholders meeting by a majority of the stock entitled to vote thereon.

ARTICLE TEN
