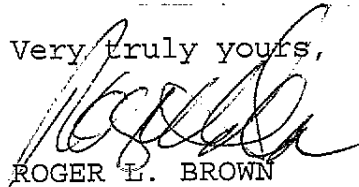

**ARTICLES OF INCORPORATION  
OF  
LRS CONSULTANT GROUP, INC.**

**ARTICLE I - NAME**

The name of the corporation is **LRS CONSULTANT GROUP, INC.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless  
sooner dissolved according to law.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of  
transacting any or all lawful business permitted under the laws of  
the United States, the State of Florida or any other state,  
country, territory or nation.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which this corporation is  
authorized to issue is 5,000 shares of common stock having a par  
value of \$1.00 each, and such shall be designated "common shares".

**ARTICLE V - PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale (by this corporation)  
for cash or property of any new stock of this corporation of the  
same kind, class or series as that which he or she already holds,  
shall have the right to purchase their pro rata share thereof (as  
nearly as may be done without issuance of fractional shares) at the

price per share at which it is offered to others (based on cash value or fair market value of property involved in the sale).

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
