**AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
CONSOLIDATE PETROLEUM ENTERPRISES INC.**

Pursuant to Sections 607.1003, 607.1006 and 607.1007 of the Florida Business Corporation Act, the Articles of Incorporation of CONSOLIDATE PETROLEUM ENTERPRISES INC. originally filed with the Secretary of State of the State of Florida on August 11, 2000, under document number P00000076278, are hereby amended and restated in their entirety as of the 30<sup>th</sup> day of September, 2005 as follows:

**ARTICLE I  
NAME**

The name of the corporation is CONSOLIDATE PETROLEUM ENTERPRISES INC. (hereinafter called the "Corporation").

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is: 9701 NW 89<sup>th</sup> Ave., Medley, FL 33178.

**ARTICLE III  
CAPITAL STOCK**

The number of shares of capital stock that the Corporation is authorized to issue is 500 shares of common stock. Each issued and outstanding share of common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

**ARTICLE V  
INDEMNIFICATION**

The Corporation shall indemnify any present or former officer or director, or person exercising any duties of an officer or director, and shall advance expenses on behalf of any such officer, director or other person, in each case, to the fullest extent now or hereafter permitted by law.

The foregoing amendment and restatement was adopted on September 30, 2005 pursuant to the written consent of the Director(s) and the Shareholder(s) of the Corporation pursuant to the provisions of Section 607.0704, 607.0821, 607.1003 and 607.1007 of the Florida Business Corporation Act. The number of votes cast for the amendment and restatement was sufficient for approval.
