

ARTICLE I - NAME

The name of this Corporation shall be:
Search I.T., Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 08/01/00

ARTICLE III - PURPOSE

ARTICLE IX - AMENDMENT


