ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I: The name of the corporation shall be GIBRALTAR LEASE FINANCING, INC.

Article II: The principal place of business and mailing address of this corporation shall be 10 Southeast Central Parkway, Suite 450, Stuart, Florida 34994.

Article III: The number of shares of stock that the corporation is authorized to have outstanding at any one time is 200, all of which are without par value and classified as Common shares.

Article IV: The name and address of the initial registered agent is Clifford J. Wagner, 10 Southeast Central Parkway, Suite 450, Stuart, Florida 34994.

The written acceptance of the initial registered agent, as required by the provisions of Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part hereof.

Article VI: The purposes for which the corporation is organized, in addition to engaging in any or all lawful business for which corporations may be incorporated under the provisions of the Florida Statutes, are as follows: Marketing, sales, advertising, and vehicle lease/finance business.

Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders entitled to vote thereon after notice.
