ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SOUTHERN MAINTENANCE SYSTEMS OF JACKSONVILLE, INC.

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts these Articles of Amendment.

SECOND: The Articles of Incorporation of this Corporation are amended by changing Article I so that, as amended, said Article shall read as follows:

ARTICLEI

THIRD: The Articles of Incorporation of this Corporation are amended by changing Article V so that, as amended, said Article shall read as follows:

ARTICLE V
