ARTICLES OF INCORPORATION OF ... AMAZING PRODUCTS, INC. FILED SECRETARY OF STATE DIVISION OF CORPORATIONS

The undersigned incorporator, being a natural person competent to contract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is AMAZING PRODUCTS, INC.

ARTICLE II

The Corporation shall commence upon the execution of the Articles and shall exist perpetually.

ARTICLE III

The Corporation is authorized to issue Ten Thousand (10,000) shares of \$1.00 par value, common stock. The rights attendant to all such shares, once issued, shall be identical in all respects.

The shares of this corporation are not to be divided into classes.

This Corporation is not authorized to issue shares in series or in less than whole shares.

ARTICLE IV
