
ARTICLE EIGHT - BY-LAWS

ARTICLE NINE - INDEMNIFICATION



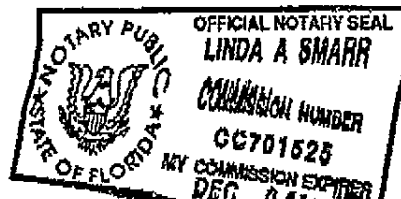


