The corporation shall have authority to issue One Hundred (100) shares of Common Stock, One Cent (\$0.01) par value per share.

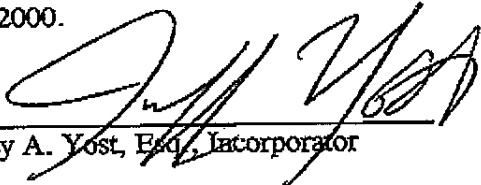
