AMENDMENT TO ARTICLES

OF INCORPORATION OF

KOENIG FINANCIAL SERVICES, INC.



The Articles of Incorporation of KOENIG FINANCIAL SERVICES, INC., as filed on August 15, 2000, charter number P00000077302, are amended as follows:

A) Delete Article VII in its entirety and add the following:

ARTICLE VII

The number of directors of this corporation shall be one (1), however, this number may be changed from time to time by lawful amendment of the By-Laws, provided each amendment shall not require a number of directors more than nine (9) nor less than one (1).

B) Amend Article X, third sentence, to provide as follows:

The power to amend the Articles of Incorporation shall be vested in the stockholders, but such amendment shall not become effectual until and unless approved by a majority of the stockholders.

C) The remaining Articles of Incorporation not specifically amended herein are hereby re-published and re-confirmed.

This Amendment is adopted this 24 day of January, 2001, and is made and adopted by all of the Shareholders of the Corporation, as required by Article X of the Articles of Incorporation, and pursuant to Florida Statute 607.1006, as evidenced by the execution hereof by all shareholders.


