The undersigned subscriber to these Articles of Incorporation is a natural person, competent to contract, and hereby forms a corporation for profit under the laws of the State of Florida.

**Article I - Name**

The name of this corporation shall be HAULING ASH, INC.

**Article II - Purpose**

The purpose of this corporation is to engage or transact in any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

**Article III - Capital Stock**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is seven thousand (7,000) shares of common stock, each having One Dollar (\$1.00) par value per share.

**Article IV - Term of Existence**

This corporation shall have perpetual existence.




