ARTICLES OF INCORPORATION

OF

**ARTICLE I - NAME**

The name of this corporation is: ABC Clothing Corporation

**ARTICLE II - DURATION**

This corporation shall have a perpetual existence commencing on the date of execution and acknowledgment of these Articles of Incorporation.

**ARTICLE III - PURPOSE**

This corporation is organized for the following purposes:

(a) To engage in the business of buying and selling fashion products and accessories, apparel, shoes, perfume and other goods whether wholesale or retail, locally or for export and to manufacture or cause to manufacture either locally or abroad, of such goods.

(b) To lease, buy or sell property in relation to its retail and wholesale business and to engage in the business of import and export, to represent manufacturers and act as agents for manufacturers and buyers. To act as procurement agents and to arrange for the purchase, storage, display, sale and dispatch of goods on behalf of others.

(c) To such extent as a corporation organized under the Business Corporation Law of this state may now or hereafter lawfully do, to do either as principal or agent, and, either alone or in connection with other corporations, firms, or individuals, all and everything necessary, suitable, convenient or proper for, or in connection with, or incident to, the accomplishment of any one or more of the objects herein enumerated or designed directly or indirectly to promote the interests of this Corporation or to

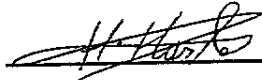
