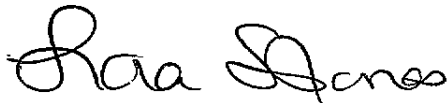

8. There are no actions pending against the corporation in the State of Florida.

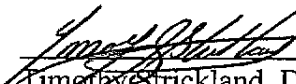

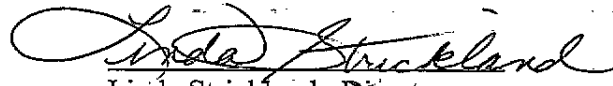

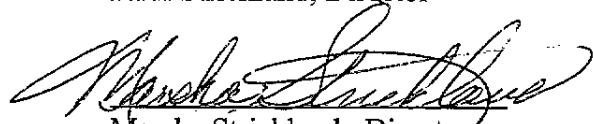
