ARTICLES OF INCORPORATION

OF

THRIFT CITY U.S.A. MANAGEMENT, INC.

The undersigned, acting as subscribers of a corporation under the Florida Corporation Law, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

MAME

The name of the corporation is THRIFT CITY U.S.A. MANAGEMENT, INC..

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of theses Articles with the Department of State.

ARTICLE III

PURPOSE

PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof as nearly as may be done without issuing fractional shares, at the price at which the stock is offered to others.

ARTICLE VII

INITIAL BOARD OF DIRECTORS

This corporation shall have three directors constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one Director nor more than five.
