This location will be for the retail selling of a Secondary Market for Baskets, Black Pottery, Handmade Kosher Chocolates and other retail items appropriate.

Local banks were discussed as to the financial backing of this storefront and general cash receivable. Mercantile Bank has been reviewed and a credit check and necessary arrangements have been made to borrow from this Institution when the time is appropriate.
