### ARTICLES OF INCORPORATION of

## MELATASSEE, FLORIDA

#### S & J DEVELOPMENT OF NORTHWEST FLORIDA, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - Name. The name of the corporation is S & J DEVELOPMENT OF NORTHWEST FLORIDA, INC.

ARTICLE II - Purpose. Corporate Purpose and Powers. This corporation is initially organized for the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607.011 of the Florida Statutes. ARTICLE III - Capital Stock The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares of common stock.
