The undersigned, being natural persons, competent to contract and for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation

ARTICLE I

NAME

The name of the Corporation is:

MISS PEGGY'S SCHOOL, INC.

ARTICLE II

DURATION

This Corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III

PURPOSE OR PURPOSES

The purpose or purposes for which this Corporation is organized are to engage in any or all lawful business or trade which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on and as permitted under the Florida General Corporation Act.

#### ARTICLE IV

##### CAPITALIZATION

The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares. Such shares shall be of a single class designated as "Common Stock" and shall have a par value of TEN DOLLARS (\$10.00) per share.

Two hundred (200) shares of stock shall be issued to each of the incorporators and the balance of Six Hundred (600) shares shall remain in the Corporation or as otherwise designated by the Board of Directors.

#### ARTICLE V

##### REGISTERED OFFICE, AGENT AND PRINCIPAL OFFICE

The street address of the initial registered agent of the Corporation is 2620 S. Conway Road, Orlando, Florida 32806, and the name of its initial registered agent at such address is PEGGY A. AVERY. #### ARTICLE VI
