# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF PLAY SAFE SYSTEMS, INC.

Original Articles of Incorporation filed with the Florida Secretary of State on August 14, 2000



# ARTICLE I

The name of the corporation is PLAY SAFE SYSTEMS, INC. (the "Corporation").

### **ARTICLE II**

The address of the principal office and the mailing address of the Corporation is 150 Palmetto Park Road, Suite 350, Boca Raton, Florida 33432.

## **ARTICLE III**

This Corporation shall have authority to issue Twenty Million (20,000,000) shares of Common Capital Stock having a par value of \$0.10 per share.

# **ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of directors constituting the Board of Directors is three (3), and the names and addresses of the members of the initial Board of Directors, who are to serve as the Corporation's directors until successors are duly elected and qualified are:
