ARTICLE I. NAME

The name of this corporation is JENNINGS CITRUS TRUCKING, INC., whose address is Hwy. 301, CR 466, Oxford, FL.

ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the date of filing of these Articles of Incorporation.

ARTICLE III. DURATION

The term of existence of the corporation is perpetual.




ARTICLE XII. AMENDMENT
