ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
VANOVER, P.A.

Pursuant to the provisions of Section 621.13 of the Florida Professional Service Corporation Act and Section 607.1006(1) of the Florida Business Corporation Act, the undersigned Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation, EFFECTIVE FOR ALL PURPOSES AS OF OCTOBER 1, 2000.

1. The name of the Corporation is VANOVER, P.A.
2. The following amendments to the Articles of Incorporation were adopted by the Shareholders of the Corporation on the 18 day of September, 2000, in the manner prescribed by the Florida Business Corporation Act:

Effective as of October 1, 2000, Article I is hereby amended to read as follows: "The name of the Corporation shall be "KEITH P. VANOVER AND ASSOCIATES, P.A."

3. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
