### ARTICLE IX

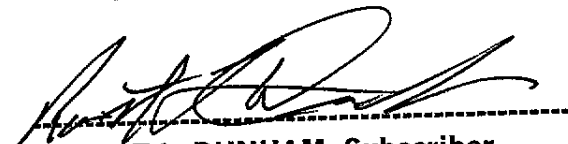

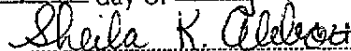
### ARTICLE XI

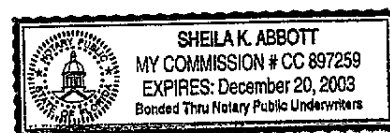
