ARTICLES OF INCORPORATION

Of

SOUTHERN EXCHANGE CORP.

The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is SOUTHERN EXCHANGE CORP.

ARTICLE II ADDRESS OF PRINCIPAL OFFICE
