In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is R. Lawrence Interiors, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 3420 Palladian Circle, Deerfield Beach, Florida 33442.

ARTICLE III

The maximum number of shares the Corporation is authorized to have outstanding at any one time is One Thousand shares, all of which shall be Common Shares with par value of \$.01 per share.

ARTICLE IV

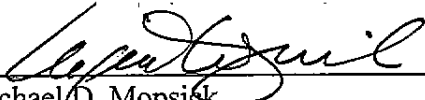
