ARTICLES OF INCORPORATION

OF

WORLDBOX GROUP, INC.



ARTICLE I - NAME AND ADDRESS

The name of the Corporation is WORLDBOX GROUP, INC. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 12360 S.W. 132nd Court, Suite 211, Miami, Florida 33186.
