I, the undersigned, as proper person acting as incorporator of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

Article I: The name of the corporation is: HAITIAN AMERICAN ASSOCIATION FOR THE CULTURAL, RELIGIOUS, AND ECONOMIC IMPROVEMENT OF HAITIANS IN PALM BEACH COUNTY, INC.

Article II: The period of its duration is perpetual.

Article III To develop religious, cultural, and economic structures for Haitian-Americans residing in Palm Beach County that will render them economically self-sufficient. To build an atmosphere of solidarity among the different Haitian organizations and sub-groups in the County that may result in the recognition of the Haitian-Americans as a political force. To engage in any lawful activities for profit and benefits of the members. Upon the dissolution of the Association, the Board of Directors shall after paying or making provision for the payment of all liabilities including all taxes of the Association, dispose of all assets of the Association exclusively for the purposes

of reimbursing the shareholder according to the percentage of their initial investments.

Article IV: The aggregate number of authorized shares that the Association shall have authority to issue is 2,000.

Article V: The Association will not commence business until at least \$1,000.00 (ONE thousand dollars) have been received by it as consideration for the issuance of shares.

Article VI: The shareholders of the Association are prohibited from transferring their shares without giving the remaining shareholders the right of first refusal according to the conditions set forth in the By-Laws of the Association for such eventualities.

Article VII: The address of the principal place of business is 12089 Regal Court W., Wellington, Florida 33414.

Article VIII: The number of Directors of the Association constituting the initial Board of Directors is 7(seven), and the names and address of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:




