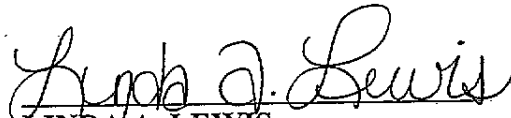
9. **BYLAWS**

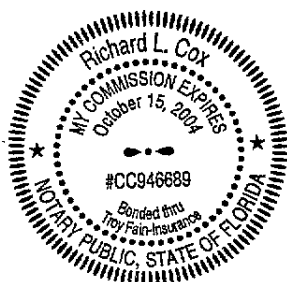

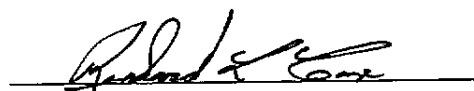

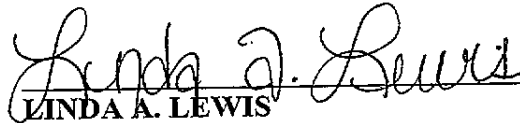
