ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is JOE FRY P.A.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business, including acting as Trustee, and that of a Real Estate Associate.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of no par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL PRINCIPAL OFFICE AND
RESIDENT AGENT

The principal office address of this corporation is 1538 W. Schwartz Boulevard, Lady Lake, FL 32159, and the mailing address is the same. The principal office and registered office addresses are the same as above. The initial registered agent of this corporation at that address is Joe Fry.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by the by-laws, but shall never be less than one (1). The name and address of the initial director of this corporation is Joe Fry, 1538 W. Schwartz Boulevard, Lady Lake, FL. 32159.

ARTICLE VIII - INCORPORATOR

The name and address of the person signing these articles is Joe Fry, 1538 W. Schwartz Boulevard, Lady Lake, FL 32159.

ARTICLE IX - POWERS

This corporation shall have the power to act as Trustee, as well as all of the corporate powers enumerated in the Florida Statute covering Professional Associations.

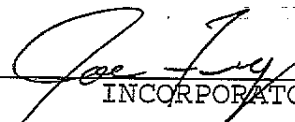
ARTICLE X - INDEMNIFICATION
