ARTICLE I. CORPORATE NAME.

The name of this corporation is: BRANFORD PROPERTIES, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS.

ARTICLE VIII. AMENDMENT.

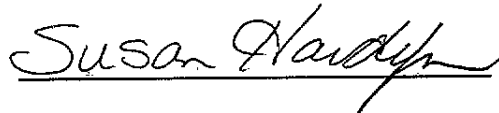

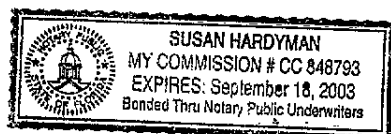
