ARTICLES OF INCORPORATION

I, Lee-Anne Perkins, the undersigned natural person, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I Name

The name of the Corporation is Create-A-Newsletter.com, Inc.

ARTICLE II Principal Office and Mailing Address
