ARTICLES OF INCORPORATION
OF
ABRC CORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

NAME AND ADDRESS

1. The name of this corporation is ABRC Corporation and the address of the corporation is 4812 S. Dixie Highway, West Palm Beach, FL 33405.

DURATION

2. The duration of this corporation shall be perpetual.

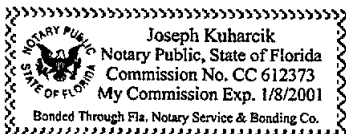

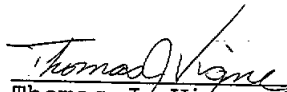
