ARTICLES OF INCORPORATION OF THE ROXY ROAD, INC.

ARTICLE I - NAME

The name of this corporation is THE ROXY ROAD,

INC. and the principal office or mailing address of the

corporation is 667 Brunswick Terrace, Deltona, Florida

32725.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of the Articles with the Department of State.

ARTICLE III - PURPOSE
