ARTICLES OF INCORPORATION OF

Trustmark Plan Administration, Inc.

Corporation is Trustmark the name of FIRST: The Administration, Inc. ("Corporation").

The street address of the initial registered office and SECOND: principal office of the Corporation is: 3832 North University Drive Sunrise, Florida 33351.

The Corporation is organized for the purpose of transacting THIRD: any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes. The duration of the Corporation is perpetual.

The Corporation is authorized to issue 10,000 shares of FOURTH: common stock, \$.001 par value and 5,000 shares of preferred stock, \$.01 par value.

Unless otherwise expressly prohibited by the Florida General Corporation Act, and except as otherwise provided in the foregoing sentence, the Board of Directors of the Corporation shall have the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to any person made, or threatened to be made, a party to any action, suit, or proceeding by reason of the fact that he is or was an officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as an officer. employee or agent of another corporation, partnership, joint venture, trust or other enterprise. No person falling within the purview of the foregoing sentence may apply for indemnification or advancement of expenses to any court of competent jurisdiction.

NINTH:

The Corporation expressly elects not to be governed by Section 607.108 of the Florida General Corporation Act as amended from time to time, relating to affiliated transactions.

TENTH:

The Corporation expressly elects not to be governed by Section 607.109 of the Florida General Corporation Act as amended from time to time, relating to control share acquisitions.

ELEVENTH: The corporate existence of the Corporation shall commence August 14, 2000.
