**TO WHOM IT MAY CONCERN:**

As per telephone instructions, enclosed please find Uniform Business Report from 2001, as well as this letter, explaining why we have not acquired a Federal Employer Identification Number (FEI).

Originally the idea was to form the corporation, to start a new business in which we will be printing adhesive packing tape, with company logos, addresses, and security messages.

We gave instructions to a lawyers firm to do all the incorporation paper for us, and the incorporation was done in the state of Florida on August 18, 2000. (Enclosed incorporation documents)

Unfortunately, after this was all done, the situation changed, and we decided to hold on the business project, because the machinery to print the tapes has to be order from Italy, and the manufacture and delivery process can take up to six months, but they require payment in advance. At this time we are still evaluating the options, and waiting to see if we can get a used machine, to do the printing.

As you can see the business was established in principle, as well as in paper, but it has not physically materialized yet. We hope to have a resolution made in the coming months, in order to finally establish the actual working part of the business.

We sincerely hope this explanation is understood, and sufficient, until we are finally able to obtain the FEI number required. In case that the above is not enough, we would like to know in time to correct.
