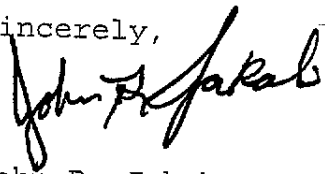

ARTICLES OF INCORPORATION

OF

JOHN JAKAB & ASSOCIATES, INC.

The undersigned incorporator of these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation pursuant to the laws of the State of Florida and does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of the Corporation is JOHN JAKAB & ASSOCIATES, INC. and the mailing address of the Corporation is 415 N. Jefferson Ave., Clearwater, Florida 34615.

ARTICLE II - DURATION

This Corporation is to exist perpetually.

ARTICLE III - GENERAL PURPOSES

The general purposes for which this Corporation is formed are to provide consultant and other services to the construction industry, and to transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.

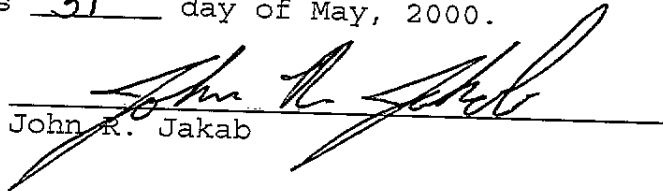
ARTICLE VIII - AMENDMENTS

ARTICLE IX - COMMENCEMENT OF EXISTENCE

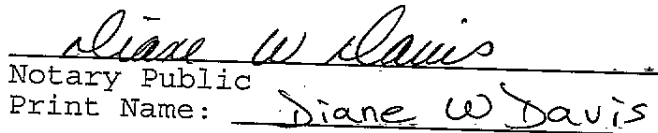
This Corporation shall be deemed to commence its existence as of the filing of these Articles with the Secretary of State of the State of Florida.
