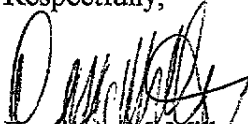

THE UNDERSIGNED, being competent to contract and desirous of forming a For-Profit Corporation pursuant to the applicable laws of the State of Florida, submit the following as and for its Articles of Incorporation:

**ARTICLE I- NAME AND PLACE OF BUSINESS**

The name of this corporation shall be MAC-MIL, INC. The principal place of business for the corporation shall be located at 1508 Martin Luther King Blvd., Pompano Beach, Florida 33060.

**ARTICLE II - DURATION**

The term of existence of the corporation is perpetual, unless dissolved sooner by operation of law or voluntarily by the Incorporator.

**ARTICLE V- SHARES AND PAR VALAUE**

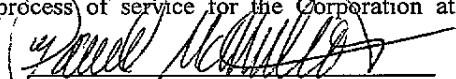

**ARTICLE VI- BOARD OF DIRECTORS AND OFFICERS**

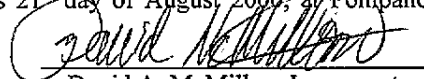

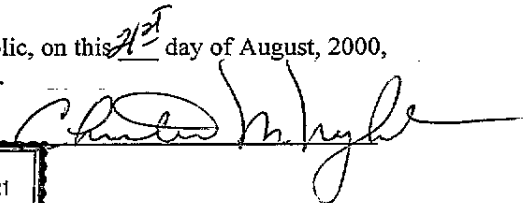
