## ARTICLES OF INCORPORATION OF EXPRESS RX, INC.

#### ARTICLE' I - NAME

The name of this corporation is EXPRESS RX, INC.

#### ARTICLE II - ADDRESS

The principal place of business is 4752 Jog Road, Greenacres,

Florida 33467.

#### ARTICLE III - DURATION

This corporation shall have perpetual existence.

#### ARTICLE IV - PURPOSE

The nature of the business to be transacted by this corporation is to operate a retail pharmacy, which sells pharmaceutical and medical supplies, sundries and other items normally sold by drugstore and for any other purpose or activity permitted under the laws of the United States and under the laws of the State of Florida and for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

#### ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of One and No/100 (\$1.00) Dollar par value common stock, which shall be designated "Common Shares".

#### ARTICLE VI - INITIAL REGISTERED AGENT

The name of the initial registered agent of this corporation is Joseph Brown.

#### ARTICLE VII - INITIAL REGISTERED OFFICE

The street address of the initial registered office of this corporation is 4752 Jog Road, Greenacres, Florida 33467.

#### ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have one director initially. The number of director(s) may be increased or decreased from time to time by the By-Laws but shall never be less than one. The names and address of the initial director of this corporation is:

#### ARTICLE X - BY-LAWS

By-Laws may be repealed or amended, and new By-Laws may be adopted, by either the Board of Directors or the Shareholders but the Board of Directors may not amend or repeal any By-Laws adopted by the Shareholders if the Shareholders specifically provide such By-Law is not subject to amendment or repeal by the Directors.

#### ARTICLE XI- APPROVAL OF SHAREHOLDERS REQUIRED FOR MERGER

The approval of a majority of the Shareholders of the Corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.

#### ARTICLE XII - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

### ARTICLE XIII - PREFERENCES, LIMITATIONS AND RELATIVE RIGHTS OF SHARES OF CAPITAL STOCK

Section 1. The holders of records of the common shares of this corporation shall be entitled to dividends at such times as the corporation is authorized to pay dividends.

Section 2. Right Upon Liquidation or Dissolution. In the event of any voluntary or involuntary liquidation, dissolution or winding up of this corporation, the holders of record of the outstanding common shares shall be paid from the remaining assets of this corporation ratably.

Section 3. Voting Rights. Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

#### ARTICLE XIV - AMENDMENTS

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any

amendments thereto, and any rights conferred upon the shareholders is subject to this reservation.

#### ARTICLE XV - DIRECTOR'S COMPENSATION

The shareholders of this corporation shall have the exclusive authority to fix the compensation of the directors of this corporation.
