**ARTICLES OF INCORPORATION
OF
TROY'S PUMP, PLACE & FINISHING, INC.**

The undersigned acting as the incorporators of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation for such corporation.

ARTICLE I - CORPORATE NAME

The name of the corporation is **Troy's Pump, Place & Finishing, Inc.**

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The general nature of the business, objects and purposes proposed to be transacted and carried on are to do all and any things allowed and permitted to be done by corporations under the laws of the United States and the State of Florida, and to the same extent as natural persons might or could, to wit:

- (a) To be a general concrete and cement finishing contractor, to carry on any type of business related thereto;
- (b) To enter into contracts for residential, commercial, and industrial concrete and cement finishing work; and
- (c) To do all and everything necessary and proper for the accomplishments of the objects enumerated in these Articles of Incorporation or any Amendment thereof or necessary or incidental to the protection and benefit of the Corporation, and in general to carry on any lawful business necessary or incidental to the objects set forth herein, it being understood that the foregoing enumeration of specific powers shall not be deemed to be exclusive, but all other lawful powers conferred by the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 500 shares of common stock, par value \$1.00 per share.

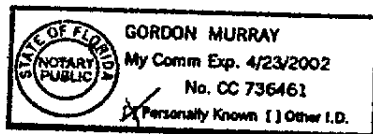
