ARTICLES OF INCORPORATION

OF

COLGATE MANAGEMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following E, FLORIDA Articles of Incorporation:

ARTICLE I

The name of the corporation is Colgate Management, Inc.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The amount of capital stock of this corporation shall be ONE HUNDRED SHARES (100) at Ten Dollars (\$10.00) par value stock, which stock shall be non-assessable to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine. All of the capital stock shall be common stock.

ARTICLE V

The corporation shall commence business on filing with the Secretary of State.

ARTICLE VI

The principal place for the transaction of its business shall be 16731 McGregor Blvd., Fort Myers, Florida 33908. That said corporation shall have the authority to do business at such other place or places within or without the State of Florida, as the corporation may be resolution designate.
