ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

Corporation or until he/she resigns or her successor is elected or appointed and qualified, whichever occurs first.

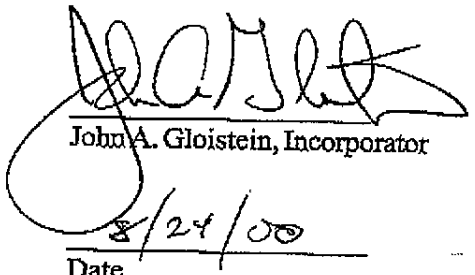
ARTICLE VII. INCORPORATOR.
