ARTICLES OF INCORPORATION OF ANTHONY J. MARTINEZ, P.A.

The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of medicine in the State of Florida, hereby associate himself with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following articles of Me 21 PH II. incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is Anthony J. Martinez, P.A.

ARTICLE II. DURATION

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as hereafter provided.

ARTICLE III. PURPOSE

The purpose of the corporation is to practice the profession of medicine.
