ARTICLE OF INCORPORATION OF

BREEZY PALMS LANDSCAPE DESIGN & MAINTENANCE, INC

ARTICLE I - NAME

The name of this Corporation is BREEZY PALMS LANDSCAPE DESIGN & MAINTENANCE, INC.

ARTICLE II - DURATION

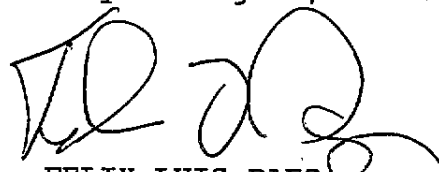
ARTICLE XI - OFFICES

This Corporation reserves the right to amend or repeal any provisions contained in these Articles, in accordance with the provisions of the Florida General Corporation Act.

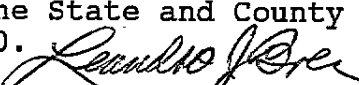
