**ARTICLE I**  
**CORPORATE NAME, PRINCIPAL OFFICE**  
**AND MAILING ADDRESS**

The name of this Corporation shall be: **C.M.S. & J., INC.**, with its principal office located at 1224 S. Peninsula Drive, #409, Daytona Beach, FL, 32118, and its corporate mailing address being P. O. Box 290729, Port Orange, Florida 32129.

**ARTICLE II**  
**NATURE OF BUSINESS AND POWER**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III**


