The undersigned subscriber to these Articles of Incorporation, a natural person to contract hereby forms a corporation under the laws of the State of Florida

**ARTICLE I — NAME**

The name of the corporation shall be **CLIENT-TELL, INC.**

**ARTICLE II — NATURE OF BUSINESS**

The purpose of this corporation is to engage in general business purposes. This corporation may also engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

**ARTICLE III — CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$1.00 per share.

**ARTICLE IV — ADDRESS**

This corporation shall have one officer initially. The name and address of the initial officer who shall hold office for the first year of the corporation, or until his successor is elected or appointed is:

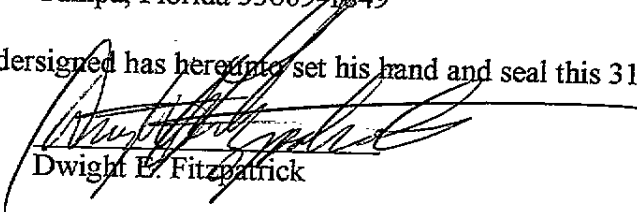
